# OADC in Action

In OADC’s mission statement, it states that our organization is “to support and work for the improvement of the adversary system of jurisprudence in our courts.” This is accomplished in part by our involvement in the review of proposed bills that will have an effect on our practices each legislative session. Most of the time, revisions in proposed legislation are made before passage. In the 2017 legislative session, an amendment to HB1470 was made, with the intention of requiring the losing party in child sexual abuse cases only to pay attorney fees. However, the amendment as written had the effect of making the losing party pay attorney fees in all civil cases. This amendment was not noticed by anyone in the legislature until after the bill was passed and signed by the governor on May 10, 2017. It was to go into effect on November 1, 2017. HB1570 containing the corrected language was passed on May 25, 2017. As of this writing, the bill is on the governor’s desk awaiting her signature.

The officers and board asked for all members to contact their legislators to inform them of the negative effects of the “loser pays” provision, and request that HB1570 be passed. Your response was overwhelming. A huge thank you to everyone who contacted their legislators (some multiple times) as this bill made its way through the final days of the legislative session. There were some roadblocks to passage, including a legislator who wanted to have the “loser pays” law in effect for a year to see how it would work (it would have been disastrous), and attention to budget measures. We made our voices heard, and it made a difference. Thank you!
